6. HEALTH CARE ARE GUARANTEED TREATY PROVISIONS GOVERNMENTS TRUST RESPONSIBILITY

- Problems with Indian Health Services (IHS)
 - o Can not get refers for outside clinics
 - Non-Indians are getting service
 - No access to or unequal access to services
 - Green Card holders- so many at White Earth it takes several months to get dental care. People travel from out of state to get dental work done because it is cheaper on the reservation, even with the travel cost added.

- The clinics are so busy that you can't make an appointment. You have to walk -in or call early in the morning and hope there is space.
- Problems with insurance. The system is purged each year, so people must resubmit the paperwork. The people are forced to sign up for a State Medical Assistance Card.
- Tribes will not honor prescriptions from outside resources; they only allow generic meds.
- People go to the Cass Lake Hospital because it is easier than dealing with the Clinic on Reservation. The Bands are racking in money with the new system. The IHS receives money for each person who walks in the door, and Mental Health Services receives "Times Three" money.
- o Elders and those on the reservation should have priority ra
- Bands have "Circle Health" and "You Care, which come out of Social Security and reimbursed" programs and reimbursement for co-pays up to a limited lifetime amount.

Marcie M. spoke about the Moose Health Research on Grand Portage.
 People are collaring animals, chasing animals for eight days in a row nonstop by helicopter and snowmobile, shooting them with darts to

tranquilize them, and bringing them into their business to run tests and do experiments on them. They are using the reservation for a laboratory. They have tons of money but have not hired Indians. There are only white males. With this climate changing for good because people on Earth won't change their ways, the moose are moving north. They're not coming back. We used to eat moose, but the hunters have found that the moose have diseases. Experimenting with these moose does not make any sense. We're never going to get them back.

Other topics discussed

- 1. Phil Brodeen is working on passing an act to Congress where the six bands will be listed independently on the federal Recognized Tribe list away from the MCT.
 - Raymond B. noted that if we split up the six bands, our strength and unity would be gone. The government already had that in mind when the casinos started. The casinos tore us apart. The Mile Lac Band has already closed its enrollment. We are going to have a hard time surviving as independent sovereign nations. TEC and Attorney Brodeen have to think carefully about the ramifications. Is MCT terminated when the Bands separately put their names on the Federal Recognition list? Then what is MCT for? What about the IIM accounts, trust Land?
 - Governments cannot own Land. MCT should not have Land. The
 government set them up as a financial institution/business. Our people
 never authorized them to be a representative government. They are an
 agency of the federal government. See the back of your enrollment card.
 - Our people used to be a Nation with Bands. WE ARE ALL THE SAME TRIBE.
 - Michaa A. asked about having seven tribes listed. He wondered how each of the six bands has more legitimacy, adding themselves to the list, escaping MCT without a constitutional movement or vote, and Sandy Lake is held to a different threshold. Adding us is just as legitimate as adding the six Bands. We should remain united. Seven sovereigns. Sandy Lake voted to join MCT in 1934. We had our local charters representative government. From 1936 to 1964, the ancestors agreed to pool assets in 1934. Our people deserve equal standing as anyone else.
 - Marcie M. stated that breaking up the six bands would be really dangerous. The people at Grand Portage talk about how the government could dissolve them. We are right on the border and feel we could be dissolved for natural security-type areas, and the government could pass a defense bill with the rider that would dissolve all of us and open us up to mining. We need to keep together. We are always under that threat, and we have to stay united.
